

# Retiree Lease Agreement and Pension Deduction Authorization Form Company Vehicle Operations

*No vehicle(s) can be obtained if this form and the driver's history have not been submitted.

**Type of Agreement:** Retiree Lease Vehicle (RL)

- I authorize a deduction from my pension/EFT payment each month in the amount of the monthly lease charge for any vehicles leased by me pursuant to the FCA Vehicle Lease Program described in the manual entitled "Retiree Lease Program Terms and Conditions." The deduction will be applied to payments due on the vehicles I lease from FCA. I understand that if I return any leased vehicle prior to the end of a lease, pension/EFT deductions may continue for the duration of the agreed upon lease period.
- I understand that if I fail to return the vehicle in accordance with the "Retiree Lease Program Terms and Conditions" document, in addition to the monthly lease payment, I will be charged a fee of \$35 per day for each day the vehicle is not returned. I hereby authorize deduction of these fees from my pension/EFT. I understand that these deductions will begin immediately upon my failure to timely return a lease vehicle and will terminate upon my returning the lease vehicle.
- I understand and acknowledge that the vehicle ("Vehicle") I am provided pursuant to the FCA Company Vehicle Program is equipped with the Uconnect® platform and associated sensors, devices, equipment, telematics and connected services, and other features (the "Connected Services") and may also include other telediagnostic and telematics equipment (together with the Connected Services, referred to as the "Vehicle Services"). **I further acknowledge and expressly agree that FCA may access, receive, collect, use and disclose information from and about this Vehicle and Vehicle Services, which may include driving data, geolocation data, crash notifications and crash data, performance and diagnostic data, and other personal information, as set forth in the Company Vehicle Program Privacy Notice found on the Retiree Lease Program website at www.chryslercocar.com.**
- I understand that our vehicles may be equipped with systems which provide us access to (1) location information; (2) crash notification and related crash data and (3) operational condition, mileage, diagnostic and performance reporting of vehicles.
- I also authorize deduction from my pension/EFT, or any other amounts due from FCA to me, for any charges for vehicle abuse (including lack of maintenance), key replacement, unpaid parking fines, excess loaner usage, administration fees, and any other charges assessed in accordance with the "**Retiree Lease Program Terms and Conditions**" document. I understand that I will be given notice of the amounts owed and the date that such deductions will be made.
- I also authorize FCA to deduct from my final paycheck, pension benefit and/or severance benefit, as allowed by law, any outstanding lease vehicle charges that are due and owing at the time I leave the company.
- This voluntary authorization is knowingly and willingly made by me, and I expressly authorize FCA to make said deduction from my pension/EFT.
- In the event that any amounts that are due from me to FCA are not deducted from my pension/EFT, I will pay such amounts to FCA within ten days of receiving FCA's invoice, bill or other demand for payment.
- I acknowledge that vehicle options may not be available, may be changed or may be removed, even after my vehicle is ordered, due to availability, material shortages or retail demand.
- **Before a lease vehicle(s) can be activated, an up-to-date driver history is required for all participants listed on this form. When adding a driver, a current driver history is only required for the added driver. The driver history must be requested from the Department of Motor Vehicles and submitted to Company Vehicle Operations within 30 days from the date on the history. Third party driver histories (ie., online services, insurance company, etc.) are not accepted. Refer to the Retiree Lease Program Terms and Conditions document for complete policies and procedures.**
- I acknowledge and agree to operate the vehicle(s) provided in accordance with the "Retiree Lease Program Terms and Conditions" document.
